### REQUIREMENTS BY STATE OF WASHINGTON

**Students must be at least 15 yrs old by first class!!**  
**Students must obtain a Washington State Learners Permit and have it in their possession at the time of every drive.**

Students must successfully complete the classroom and driving portions of curriculum before they will be issued a Certificate of Completion. The final test must be passed with a minimum of 80%.

**If student misses more than three (3) classes\* they are required to retake the entire (15) class course again.**

\*Must have prior authorization to miss more than 3 classes.

To join a course you must start before the 3rd class has been completed!!

### CLASS RULES

Enrollment form must be completed and signed by both student and parent by end of the first class. All records and test require your full legal name.

**Classes must be passed, completed, or made up before you can take the final written exam. (class 15)**  
**All classes and the final written exam MUST be completed within 20 days of the original exam date or the student could be required to start the course over and fees may apply.**

The State requires that the classroom learning and the drive practices be integrated and contiguous.

**Students need to do 3 drives during the time of their classes and continue on with their drives weekly after their final class until the drives are completed.**

Students *not* completed in a contiguous manner will need to follow state requirements and start the program over. A \$100.00 reinstatement fee will apply.

### STUDENT EXPECTATIONS

1. Disruption of class will not be tolerated and you will be asked to leave with no grade for the day, the class will need to be made up.
2. Disrespect of staff or instructors will result in dismissal without reimbursement.
3. Cheating is immediate dismissal from the program.
4. We have a "0" tolerance drug policy.
